## Astounding election result

**Ryan Fuller, Conservative Leader of HDC has lost his seat in one of the most hotly contested District Council elections of the past 50 years. Not only that but the Conservatives have lost overall control of Huntingdonshire.**

Thursday saw the Conservative's domination of the District Council melt away as the results were announced. Perhaps the biggest shock was in St Ives West where Julie Kerr, an Independent, beat the now ex Leader of HDC, Ryan Fuller by 27 votes on a turnout of 40.1%. Julie is the first person in 32 years to be elected to the District Council from St Ives who is not a Tory, despite the Town Council being Independently controlled since 2008.

In St Ives East ward there were wins for two Independent candidates Michael Burke and Shariqa Mokbul. In St Ives South the rout was complete when Lib Dem Nic Wells and Labour's Cath Gleadow were elected. See p3 for results.

## Returning Officer refuses Riverporter access to count

The counting of votes for Thursday's elections took place on Friday morning in the St Ives Indoor Centre. *The Riverporter* delayed printing so we could bring you the election results straight away. We requested that one of our editors could attend the count in order to get the results in print asap. This request was turned down and despite an appeal the Returning Officer, Ms Joanne Lancaster, refused to admit us. HDC's decision said: *We do have relatively limited space to safely accommodate the media interest which has been allocated on a first come first served basis, and in doing so the Returning Officer has used their discretion in deciding media representation at the count venue. This is in accordance with the advice received from the Electoral Commission.*

This advice states that Returning Officers should include space and opportunity for the media to report on the results of the elections but do have discretion to decide which representatives of the media they allow to attend.

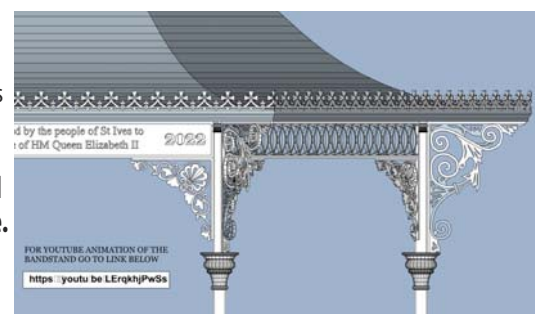
## BANDSTAND UPDATE

It was hard coming to terms with some of the conventions on my first stay in France. But I was here for eleven years so hopefully I got it right eventually.

There's the business of kissing for instance. Kissing as a daily greeting I found a charming innovation. I loved watching my daughter leave the house for school and oh so naturally kiss each friend, girl or boy, as they met in the street. It seemed so much nicer than the blushing, stuttering, giggling uncertainty of teenagers meeting in an English street. (This was in the eighties.)

But here again, all is not as simple as it seems. For instance - how many kisses?

It's terribly embarrassing if you are expecting two and three are offered. The last one either seems to have been rudely rejected or falls on your nose as you withdraw your face and straighten up. I've learned now that it's rare to see just the two kisses - left, right - as depicted in film and stage portrayals of stock Frenchmen. Three is much more common - and in Paris it's always four.

There was the little old man with whom I struck up an acquaintance. He often passed the plot I was struggling to bring into submission. at the side of the house. I was losing the battle. It was refusing to look anything like an Essex country cottage garden. He appeared at the door one evening with a huge bunch of paeonies, having noticed my failure to raise anything but a few pale pansies and some droopy gladioli. Impulsively I embraced him and was condemned to do so from then on every time we met in the road, at the market,



the baker's or the bus-stop. Because, once begun, the kissing must continue.

It was the same with my hairdresser.

I gave her a present the first Christmas. This came as a great shock to her as it's not the habit over there.

'Il faut que je vous embrasse pour vous remercier!' [I have to kiss you to thank you!] she cried.

From then on I had to remember to single these two people out even if they were amongst a crowd at the Village Fête or in the middle of the supermarket. Left, right, left right - the cheek must be proffered. For to offer a hand to be shaken having once saluted more warmly is equivalent to the coldest of British snubs.

## Beware the so-called 'Independents'

Is the message sent to voters at the last minute by Ryan Fuller in the hotly contested St Ives West Ward. The letter, sporting Mr Fuller's Distict Council email address, seemed to be a desperate attempt to smear his opponent.

Whatever the results, these election has seen quite a high level of acrimony, particularly from the current Leader of HDC, Ryan Fuller who has tried to undermine one of his opponents, the Independent Julie Kerr.

In an email sent to Mrs Kerr on 28 April, using his District Council address, Mr Fuller described her leaflet as 'full of dishonesty, lies and smears'. He demanded that she provide evidence about her statements and stop distribution of the leaflet before asserting that he was disappointed that she had "resorted to such personal smear tactics and dishonesty".

Of course the email was an attempt to upset the opposition, particularly someone new to the heat of a political campaign, as none of his assertions were correct. Indeed Mrs Kerr's leaflet couldn't have defamed Mr Fuller as he wasn't mentioned on it.

Mrs Kerr told *The Riverporter* that she specifically did not want to run a negative campaign degrading the opposition. Indeed she wanted people to vote for her so that she could be 'the catalyst for the change that we desperately need. I am passionate about promoting St Ives and enabling community empowerment through consultation.'

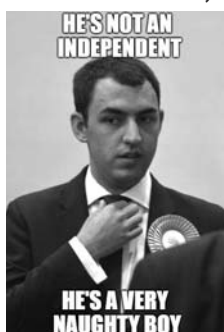
This is what she wrote in the last issue of *The Riverporter*, whilst Mr Fuller declined the offer to make a statement.

Mrs Kerr did complain about Mr Fuller's leaflet, which she claimed attributed other people's views as hers, but unlike Mr Fuller she made an official complaint through the proper channels.

### A new level of hypocrisy

It seems that Mr Fuller's attempt to intimidate Mrs Kerr failed. In fact it spurred her on to canvas every house in the Ward and this may have resulted in his desperate last minute letter to voters as his support seemed to be ebbing away.

It is quite a remarkable letter, seemingly written by a candidate that feels he may lose. It's a last minute attempt to undermine the opposition and scare residents who might vote for 'a coalition of chaos' as he describes them. Once again Mr Fuller accuses Mrs Kerr of lying and he lists his achievements as reason's to vote for him. In fact many of his achievements



are not his alone and would probably have happened anyway. His claim that he helped secure development funding to rebuild Thorndown School will certainly rankle with some Governors.

His wildest claim is that the Independents in St Ives are 'operating in league with other political parties to install a coalition of chaos'. A surprising comment from someone who stood as an 'Independent For St Ives' and caused chaos at the last Town Council elections.

Local police issued a news report last week to announce that they had discovered and seized a large hoard of cannabis. The cannabis, and they say much more, was seized using a warrant at a property in Great Farthing Close. The report suggests that the seized quantity has a street value of about £200,000. The police go on to say that while cannabis remains a class B drug, they will continue to seize it and seek to prosecute those growing and selling it.

### Jubilee Celebrations should be fun

Planning is continuing for 4 days of celebration in St Ives from 2nd to 5th June with a military parade and a Big Jubilee Concert the main feature on Saturday 4th in Market Hill.

**The programme includes the following:**

#### THURSDAY 2 JUNE - Coronation film and Beacon lighting.

**Coronation Film** A film of the Coronation in 1953 will be shown at 6pm in the Corn Exchange, prior to the normal screening of 'The Duke' by Screen St Ives.

**Beacon Lighting and evening picnic.** After sunset a Beacon will be lit on the roof of All Saints Parish Church. The evening will start at 7.30pm with an opportunity to socialise. There will be a licensed bar and you are encouraged to bring your own food and enjoy an evening picnic with friends. At 9pm there will be a service followed by lighting of Beacons at 9.45pm.

#### FRIDAY 3 JUNE - Multi Faith Service & Singing in the Reign.

The Vicar of St Ives will lead a multi-faith service for the town's religious and community groups in Market Hill from around 11am. **Singing in the Reign** - see page 1.

#### SATURDAY 4 JUNE - Exercising the Freedom and Big Jubilee Concert.

There will be parade by the Corps of the Royal Engineers, 2331 St Ives Squadron ATC and the Army Cadets Force in Market Hill from 10am. The usual Farmers' Market will also take place and later, it's the **Big Jubilee Concert** featuring The Candy Girls and The Amazing 80's. Entertainment is expected to start around 3pm with the main concert starting around 7pm.

#### SUNDAY 5 JUNE - The Big Broadway Lunch

St Ives Town Council have applied for a road closure so that The Broadway will be free of vehicles and can be used by residents to hold a giant picnic lunch. Bring your own food and seating and join in a massive picnic, that hopefully will include buskers and entertainers. With The Broadway free of traffic, it is hoped that a one-way traffic system (via St George's Road) will allow vehicles to unload at The Waits, so you can bring your food, chairs and people close to area set aside for the lunch.

This is a letter sent by Betty Crisp, a 99 year old resident of St Ives, to our MP, Jonathan Djanogly, about the relocation of asylum seekers to Rwanda. It was also sent to Erik, who thought our readers should see it.

#### Dear Mr Djanogly

I am a 99 year-old constituent of Huntingdonshire living in St Ives for over 30 years. During my life I worked as a nurse during WW2 and I have been an active member of Amnesty International, including the St Ives group, and Oxfam for 50 years.

I am extremely shocked and concerned about your government's proposals to relocate asylum seekers to Rwanda. The plans are not only infeasible and expensive, but are simply morally wrong. These plans will place asylum seekers and their families at great danger and trauma

The idea that this is justified by the numbers of 'economic migrants taking advantage of the asylum system' simply does not hold as 82% of applicants were granted refugee status, with almost half [of the others] being granted status on appeal. Further, in accordance with the 1951 Refugee Convention, there is no illegal way to claim asylum.

Boris Johnson claimed that 'Rwanda is one of the safest countries in the world', yet only months earlier he condemned Rwanda for human rights abuses. These abuses are corroborated by other refugees relocated to Rwanda by Israel on a similar scheme, and include threatening and degrading behaviour and the confiscation of their key identity documents.

Please oppose the plans of this government to relocate asylum seekers to Rwanda for asylum processing and show your support for the UK's international commitment to safe asylum and refugee-hood.
