n Tuesday, Cambridgeshire County Councillors voted by 31 to 25 for St Ives to be part of a unitary authority with the ity of Peterborough and Fenland District, effectively creating a North-South divide and cutting St Ives' natural links with Cambridge.

**Local Government Reorganisation** (LGR) is the process that the UK Government is using to reduce the number of councils in the country and try to simplify the way we all receive our services.

Tuesday's debate at Shire Hall was to choose an option to send to the Government as to how this can be achieved in Cambridgeshire.

It is important to say that the Government has suggested certain conditions and given little time for councils to do a well considered job, a point raised by several councillors during the debate.

All the local councils can contribute to the process, including the five district authorities and the two city authorities, all of whom might close should the proposals go ahead.

There is no guarantee that any of the 'districts will agree with the county that Option A is the best one. In fact it is highly likely that some

councillors who are both county and district councillors may end up voting the opposite way when their district votes for an option.

It was suggested by the Government that the reorganisation should keep the existing district boundaries, and the County Council have stuck to that instruction, despite its obvious fault.

Although three options were originally put forward, see below, only Option A was chosen by Council leaders to vote on.







Proposal A

Lib Dems take advantage

The Lib Dem group, which is the largest on the council, effectively run the authority and they put their weight behind Option A. It would appear this was largely to ensure a Lib Dem majority in a future southern authority.

All but one of their 31 councillors, plus Independent Tom Sanderson, voted for Option A (1 abstained).

#### St Ives councillors vote against

The other 25 councillors who voted against, included all Conservatives, Reform and Labour councillors plus St Ives' Julie Kerr and Alex Bulat. Alex explained that this Option is bad for St lves residents, 'Who are more likely to work in Cambridge and use the busway which is directly connected to Cambridge from the Town.

She pointed out that none of the

options worked for St Ives and with 60% of Huntingdonshire residents against Option A it isn't surprising that HDC are looking to go on their own. She also questioned the process that didn't supply business data for the other options and therefore couldn't be assessed.

#### A better solution?

One option, suggested by consultants but not considered by the Council, would be for the whole county to be the unitary authority. This could be the most cost effective solution, creating a large enough authority that already works with other suppliers of services, such as health, social services and education and creating big savings by doing away with the 7 'district' councils.

## Confusion reigns over A141 Improvement Scheme

in the town and its surrounding

Proposals to improve the road network in St Ives, put forward by Cambs CC, CPCA and HDC, have caused total confusion for councillors, community groups and the public due to the lack of information in the latest presentation material.

It should be said from the outset that these are just proposals and may not see the light of day.
However this latest iteration has some serious implications for St Ives.
One of the main problems is that the rather crude map (right), showing a banned right turn into Needingworth Road from St Audrey Lane and a Bus Gate on Meadow Lane needed explanations that are not in the document.

As a result of the letter we received from Roger King (right), *The Riverporter* attended the first public event in Huntingdon to try to understand the proposals, in particular the:

- Exact location and function of the Bus Gate on Meadow Lane
- Improved capacity at B1040/ A1123/ Harrison Way roundabout
- Banning of right turn from A1123 into Needingworth Road
- Increased green time for A1123 at Ramsey Road junction signals
- Extra lane southbound on Harrison Way between A1123 and Meadow Lane.

We can report that the consultants told us that the Bus Gate would be located between the entrance to the Cattle Market Car Park and Needingworth Road, thereby allowing cars to enter the car park from Harrison Way.

It would stop traffic from both directions but it is intended to operate in the mornings only.

The 'No Right turn is into Needingworth Road, only from the A1123 and that the extra lane on Harrison Way would be from the A1123 to just beyond the busway crossing at Station Road.

Here is Roger's letter which sums up some of the issues well.

#### Dear Editor,

I'm sure you will be only too aware of the proposed traffic changes in St Ives, seemingly aimed at reducing 'rat runs' and freeing up the A141. Hidden within these are dramatic changes to the traffic flow through St Ives, which can only damage trade and inconvenience residents. It may also be the death-knell for Waitrose and its car park. I have attached a copy of my response to the 'consultation'. I'm sure you know all about this - but I have found that a depressingly large number of St Ives residents do not. You are a great way to reach them! Regards Roger King



I have lived in this corner of St Ives for over 60 years and have yet to see any evidence of a 'rat run' on these roads: just a typical rush-hour build up of traffic at school times and early evenings, which is nothing compared with how it was before Harrison Way was built. By far the biggest hold up on the roads around St Ives is the evening traffic build-up, mostly comprising north-bound traffic on Harrison Way. It is no coincidence that this appeared after the construction of

north-bound traffic on Harrison Way. It is no coincidence that this appeared after the construction of the busway due to the inclusion of a pedestrian crossing into Station Road from the Park & Ride. This is where the traffic problems stem from - these proposals will merely move the queues up to the A1123. There is no 'rat run' worthy of the name in St Ives - we need a footbridge, that's all.

Stopping residents and businesses accessing the bypass at its closest point to the town will not achieve anything positive. Businesses will suffer (Waitrose lorries having to come right through the town from the other end, until Waitrose gives up the unequal struggle and closes), services will become even less accessible and emergency services will find access and egress very difficult.



Under these proposals I have calculated that my daily journey to the south of St Ives will change from 0.1 mile in 1 minute to 2.6 miles and 12 minutes! I will need to drive north to reach the A1123, both options for this involve having to drive down narrow residential roads with school crossings, putting young lives at risk.

The Riverporter did suggest that the people who drew up these plans didn't know St Ives and indeed that was confirmed by the consultant from Atkins, the company employed to do the work.

Of course it's not so long ago that the disastrous Master Plan for St Ives was expensively drawn up by consultants who knew little of the town and who thought St Ives could do with a pontoon on The Quay similar to one in Chicago.

#### Trying to be positive

It is good that traffic flows, active travel (walking and cycling) and public transport are being considered as the new Local Plan sees large increases in homes in our area and without better transport routes, the area will not cope.

It is important that residents offer their opinion on the proposals, which can be found at https:// yourvoice.cambridgeshire.gov.uk Simply search A141.

If you missed Thursday's display of the proposals in the Corn Exchange don't worry as you can still see them at the Burgess Hall on Thursday 13th November between 2pm and 7pm. Your voice will matter because without your feedback these proposals could get the green light unless enough people say why they won't work.

## St Ives turned pink and blue



Alongside a Ribbon Memorial Display adorned with pink and blue named ribbons outside St Ives Methodist Church during Baby Loss Awareness Week (9th to 15th October), for the first time we saw the Town Bridge lit up in pink and blue during the Wave of Light at the end of the Week.

Also, with help and guidance from the wonderful team at St Ives Methodist Church, we hosted a special Remembrance Service - a touching reflective short service, culminating in lighting a candle for babies no longer with us.

Few experiences can compare to the trauma and pain of baby loss. Currently in the UK, 13 families a day suffer the heartbreak of losing their baby before, during or shortly after birth. And at least 15% of pregnancies end in miscarriage.

Councillor Laura Thompson from St Ives Town Council (pictured above in front of the display of ribbons), the volunteer who has organised the events, said: 'Turning St Ives Town Bridge pink and blue, especially on the 600th anniversary of the bridge this year, sparked conversations about the impact of baby loss and let local bereaved parents know we stand with them. It has impacted so many people in our local community. The beautiful ribbon memorial display once again showed people that they are not alone and gave them an opportunity to remember their precious babies. 


This program builds on previous government
